Everything You Wanted To Know About the Kanye-Inspired 'Coinye' But Were Afraid To Ask

Some entrepreneurs are using Kanye West to launch a cryptocurrency - so what does that mean, again?

You would think a Twitter account that popped up Tuesday called "Coinye West" was a parody account created by some econ nerd-cum-Yeezy fan. It in fact is the handle of a new digital currency inspired by Kanye West that, as the creators confirmed to VICE Thursday, will launch Jan. 11. Confused yet? So were we. Here's a primer.

So Kanye has his own currency now?

Not exactly. It looks like West — surprisingly, considering the lengths he'll go to for self promotion — has nothing to do with it. Some techie monetary entrepreneurs — who for the time being "want to stay sorta anonymous in case Kanye gets pissed off" — are launching a cryptocurrency using West's likeness and some clever punning called "Coinye West."

Cryptocurrency ... excuse me, what?

Cryptocurrencies are digital monetary systems. Users can use these networks to buy and sell things online, usually anonymously and almost like PayPal, but in a decentralized fashion. You may have heard of Bitcoin, the 4-year-old form of digital currency that attracted congressional attention in November. It went on a boom-and-bust ride last year, with the price of a bitcoin skyrocketing above \$1,000 in November only to crash 50 percent.

Because it is online, anonymous and decentralized, Bitcoin and other cryptocurrencies get a reputation as being especially useful for illicit purchases (it was the accepted currency of the recently shut down illegal drug trafficking website, Silk Road). However, the rise of BitPay, BitGive and other platforms that use Bitcoin have given it some legitimacy, and attention now has turned to how it could be regulated.

So how does this all work?

Similar to how a treasury prints cash, bitcoins are released in a process known as "mining," in which users' computers compete to solve algorithms to win bitcoins (the algorithm gets increasingly harder so that the race will occur every 10 minutes or so and the bitcoin rewarded is halved every four years, meaning the bitcoin supply is finite). Coinye's creators say they will release their own front-end mining program called CoinyeMiner, which according to them will be more user-friendly than the mining programs used by other cryptocurrencies.

Wait -- they named the mining program 'CoinyeMiner,' and not 'Gold Digger'?

I know, missed opportunity, right?

What's the point of naming your weird online currency after a megalomaniac, Kardashian-loving rapper?

Well, this is the point: attention. For these currencies to work they must have users, and the more users they have the more stable they'll be. Just last month, some Internet geeks created a cryptocurrency called Dogecoin – inspired by 2013's Meme of the Year, a Shiba Inu dog named Kabosu – and its value surged 900 percent in a week while its competitor currencies stumbled.

"There was this trend effect of people thinking it was associated with something cool and trendy," says Reuben Grinberg, a lawyer in the financial

institutions group of the law firm Davis Polk & Wardwell LLP. The Coinye creators likely are hoping for a similar effect. "My guess would be is that they're trying to profit on something associated with [Kanye's] name."

As Coinye creators told VICE, "We chose to represent Kanye because he is and always has been a trendsetter, and he's always keeping things unique."

Should I buy Coinye?

Though the Coinye creators say their program will be more accessible than other cryptocurrencies, they haven't really specified how.

"As more people get involved in mining this currency, it's going to be difficult for everyday people to get access to these coins and it's going to be people with professional setups who profit the most," Grinberg explains. So you might be better off sticking to the more established Bitcoin.

Also worrisome, Grinberg says, is the kind of users Coinye seeks to attract: Kanye fans, rather than economists, math whizzes and techies who are known to get involved in cryptocurrenices. Cryptocurrencies are very risky, and non-economists buying in out of a love for Kanye could lose a lot of money if they don't know what they're doing.

"These are not the people! would say who should be getting involved in digital currencies," Grinberg says.

How many Coinye will it take to buy a 'mayonnaise colored Benz'?

We won't know until the currency launches, but as of press time, a \$300,000 Mercedes-Benz costs about \$384.73 in bitcoin.

I bet Twitter is loving this.





If you thought Internet-meme-based cryptocurrency Dogecoin was ridiculous, then Kanye-West-based altcoln Coinye West will probably just make you angry.

Named after Yeezus himself, Coinye West is set to launch on January 11, at 11pm ET, according to the cryptocoin's creators, who tell Vice's Noisey blog that they hope it will help bring the nebulous world of digital currencies into the mainstream.

"Our goal with Coinye West is to make it easier for people to use cryptocurrency," Coinye West's unnamed creators tell Noisey. "Right now, it's kind of a dark art for people to mine coins. We plan on releasing a front end to the "mining" programs called CoinyeMiner. It will make things a lot more simple and people will be able to make their own coins."

Coinye West's creators say they chose Kanye as their cryptocurrency mascot because "he is and always has been a trendsetter." But despite the creators' enthusiasm for the rapper, West has not endorsed the crypotocurrency, and is apparently no way involved with it - and that could be a problem.

"We're really not sure how Kanye is gonna react to this," says Coinye's creators. "We hope he loves it, but if he doesn't, he really isn't someone we want to piss off."

Coinye West is only the latest so-called altcoin to launch over the past year. Some, like Litecoin, trade at a fairly high value - though nothing close to the \$750+ exchange rate Bitcoin currently enjoys. Most wallow in the fraction-of-a-penny range - a place where Coinye should probably get comfortable.







On January 6, the creators of the cryptocurrency, who have capitalised on the media's recent fascination with Bitcoin. received a cease-and-desist letter from West's law firm, Pryor Cashman.

The rapper's attorney, Brad D Rose, accused Coinve West, as it was known at the time, of trademark infringement, trademark dilution. unfair competition and cyberpiracy.

"Given Mr West's wide-ranging entrepreneurial accomplishments, consumers are likely to mistakenly believe that Mr West is the source of your services or [had] endorsed the cryptocurrency," Mr Rose wrote.

Despite Mr West's threat that he will sue any business that accepts the novelty currency, Coinye launched last night, 4 days earlier than it had originally intended, and posted on its website, "We are being attacked with fishsticks and must launch sooner."

The altcoin's developers have responded to the rapper's attempts to shut it down by changing the name from Coinye West to Coinye, altering the logo image and launching the currency early.

On the forum bitcointalk.com, CoinyeCoin developers also explained that "The name 'Coinye' is intended solely as parody, not an indication or implication of endorsement or involvement."

Interviews given to the Wall Street Journal and ArsTechnica indicate that the anonymous creators of Coinye hold anti-establishment and anti-capitalist beliefs, having been quoted as saying that "anarchocapitalism is coming, it can't be stopped. Whether it has a symbol that looks like a dollar, a dog, or a cartoon picture of a rapper, it's all the same thing."

The creators, who identify themselves "just a few guys who want to take cryptocurrency to the mainstream," tweeted the rap icon in December to ask him his thoughts on the project, and more recently told Vice they "hope he loves this."

With this development, the creators probably have their answer.

Pop provocateurs tend to age awkwardly, and M.I.A. often tries a little too hard to foment outrage (although it's hard to trump having Julian Assange as an opening act). Still, her fourth album is plenty provocative and outrageous-sounding: dance music that's twitchy like a slug of Third World-exploiting coffee, shot through with neonbright digital distortion and mutated South Asian instrumentation. And her most potent weapon is still her dry, venomous, word-savoring voice.



Between the late-'70s and the mid-'80s, William Onyeabor released eight albums on his own Wilfilms label in Nigeria. Then he dropped out of public view altogether, and the peculiar genius of his percolating, synthesizer-centered grooves was lost to everyone but fanatical record collectors. This long-overdue career survey is riveting and unfailingly funky; you can hear the inspiration of Fela Kuti's Afrobeat, and sounds that would turn into new wave a few years later, but Onyeabor mostly sounds like nobody else on the planet.








3. mbv, My Bloody Valentine

Twenty-one years after My Bloody Valentine's epochal Loveless, guitarist/singer Kevin Shields' endless string of assurances that they were almost done with a new album were abruptly replaced, one night, by an announcement that it was done and ready for download. Boom. (The late-'90s-style drum-'n'-bass rhythms of "Wonder 2" suggest that they really had been working on it all along.) Shields is apparently the kind of perfectionist who can actually let go of something once it's perfect: mbv's torrential wash of million-layers-deep guitars and purring honey-power voices is as glorious as he wanted it to be.

2. Modern Vampires of the City, Vampire Weekend

Vampire Weekend does the same thing with music that really clever writers do with words: their vocabulary's immense, and so is their command of idiom and tone, and they use those gifts to be thoughtful and evocative rather than just to show off. (Unsurprisingly, singer Ezra Koenig does that with words, too.) You can spend days unpacking their third album's allusions and juxtapositions, or you can just ride the ripples of its wry, ridiculously catchy meditations on the shift from over-comfortable youth to uncertain maturity.

1. Yeezus, Kanye West

Kanye is the best there is, and he's still not as good as he thinks he is. Has there ever been another great album this bitter, this entitled, this abrasively unsatisfied — or this self-aware about it? (See its most-quoted joke: "In a French-ass restaurant/Hurry up with my damn croissants.") Yeezus is brief, spare, nasty, and as charismatic as a cult leader. Its music grinds sourly or lurches like an old rollercoaster; West's voice drips contempt or hides behind frigid Auto-Tune effects. But Yeezus, has he ever got raw power.







We were seduced by darkness at least five times (electronic, rock, classical, metal) and loved sounds that we call "delicate" (three out of four made by men). "Wry" hit the spot twice (country singer again, and a pair of



KACEY MUSGRAVES SAME TRAILER DIFFERENT PARK


The biggest quiet story in popular music this year involved women singer-songwriters who kept their tongues in their mouths and told the truth of ordinary lives. Texas-born, Nashville-based Kacey Musgraves set the standard with a major label debut that sounded like current country while avoiding all the clichés about Chevys and flags and spring break debauchery. Instead, Musgraves sang in her been-there-done-that drawl about restaurant workers waiting for a break, small-town kids slowly morphing into the parents they resent and strong women who know that a hook-up might be just a hook-up and Prince Charming is sometimes best kept as a memory. Then there's the anthem "Follow Your Arrow," the "Same Love" of country, which turned YOLO into a means of real liberation. By year's end, Same Trailer Different Park was winning awards, Musgraves was writing songs with Katy Perry, and she had fully proven that country belongs as much to women with smarts as to men with trucks. —Ann **Powers**

Right before Yeezus, his sixth studio album, crashed into the public sphere in June, Kany e West told the New York Times, "I understand culture. I am the nucleus." The album almost justifies such supreme egotism. Soundwise, it builds something new, juxtaposing avantgarde industrial and electronic innovations with the High Romantic hip-hop West had already perfected. And then there's what West says in its forty rampaging minutes. Sex fantasies and a dirty lover's despairing mea culpas emerge from West's confused id, while his exacting superego places his urges within the context of American racism, international celebrity and the infinite void of consumerist decadence. 





It's apparent from jump. Right from the opening synth squalls of "On Sight." From the electro ticktick-tick. From the bass turned way past distortion. This is something new. Sounds you haven't hear before. Like a spaceship crashing in your backyard. You can't help but look, you can't help but approach. Out of curiosity if nothing else at first. You're being pulled forward by your ears. Kanye's making a statement. "I'm from the future. I'm here to show you how it's going to be."

Re: Infringement of KAYNE WEST Mark and Other Violations

Dear Sir or Madam:

This law firm acts as litigation counsel for Kanye West and his affiliated companies. As you are aware, Mr. West is an internationally renown musical artist, songwriter, producer, film director and fashion designer, to name just a few of Mr. West's endeavors. Mr. West has won twenty-one Grammy Awards, making him one of the most awarded artists of all-time. He has been named one of the 100 most influential people by *Time* magazine and is routinely listed by *Forbes* as one of the most successful people in the world.

Mr. West's tremendous success and notoriety has catapulted the KANYE WEST brand into a commercial asset of incalculable value. In addition to his common law rights, Mr. West owns numerous federal trademark registrations for the KANYE WEST mark for various goods and services as well as several pending applications. See, e.g., U.S. Reg. Nos. 3,648,799; 3,648,800; 3,648,801; 3,648,802; 3,648,803; and 3,648,804. Without doubt, the KANYE WEST mark is famous and is entitled the broadest protection under the law.

We write to you concerning your unauthorized use of the COINYE WEST mark in connection with a purported cryptocurrency that may be available on January 11, 2014. We have recently learned that you are promoting the COINYE WEST cryptocurrency through the coinyewest.com website, on Facebook at facebook.com/coinyewest and on Twitter at twitter.com/CoinyeWest. The COINYE WEST mark is substantially similar to the KANYE WEST mark in sight, sound, meaning and commercial impression. Interviews with the founders of the COINYE WEST cryptocurrency leave no doubt that your clear intent is to trade upon the goodwill associated with the KANYE WEST mark and Mr. West's international fame and notoriety. In particular, several news sources have quoted the developers as stating "We chose Kanye because of his trendsetting abilities and his originality," and also that you have decided to remain anonymous "in case Kanye gets pissed off." Such statements support a finding that your infringement is blatant and willful.

Given Mr. West's wide-ranging entrepreneurial accomplishments, consumers are likely to mistakenly believe that Mr. West is the source of your services or is, at the very least, affiliated with, or has sponsored or endorsed the cryptocurrency. The likelihood that consumers will be confused is heightened by the unauthorized use of an image of Mr. West on the coin:





Your actions constitute, *inter alia*, willful trademark infringement, unfair competition, cyberpiracy and dilution in violation of Sections 32(1), 43(a), 43(c) and 43(d) of the Lanham Act, and subject you to monetary damages including treble damages based on the willful nature of the infringement.

In addition to the Lanham Act claims, you are also liable under the Copyright Act for misappropriation of Mr. West's music videos embedded in the <coinyewest.com> website. Your actions also violate Mr. West's right of publicity under state law, which subjects you to further liability.

Mr. West takes these violations of his intellectual property very seriously and seeks to resolve this matter without resort to litigation including filing an application for a temporary restraining order. Accordingly, please immediately confirm that you and all of your affiliated companies, employees, consultants, agents and representatives will immediately:

- 1. cease and desist from any and all use of the mark COINYE WEST and any versions of that mark including COINYE;
- cease and desist from any and all development, sale, distribution and promotion of any and all products and services in connection with the mark KANYE WEST, or any names or marks confusingly similar to KANYE WEST, including, but not limited to, the COINYE WEST and COINYE marks:
- 3. cease and desist from any and all use of Mr. West's copyrighted material including his music videos;
- 4. deactivate the website located at <<u>coinyewest.com</u>>, unlock the domain name to allow it to be transferred and provide us with the authorization code to facilitate such transfer;
- 5. deactivate all social media accounts created and/or used in connection with the COINYE WEST mark, including, but not limited to, the Facebook account located at <facebook.com/coinyewest> and the Twitter account located at <twitter.com/CoinyeWest>; and



6. cease all use of Mr. West's name, image or likeness in connection with any product or service.

We further demand that you immediately confirm to us, in writing, no later than 5:00 p.m. E.S.T. on January 6, 2014, your intent to comply promptly with our demands, failing which our client will proceed with the necessary measures to protect its valuable rights, including, if necessary, securing injunctive relief in court against you, and recovering all appropriate damages, including treble damages, attorney's fees and costs.

If you fail to comply with these demands, we will notify the cryptocurrency community at large of your infringing actions and pursue all legal remedies against any business that accepts the purported COINYE WEST currency. Specifically, Mr. West will pursue claims of contributory trademark infringement and contributory unfair competition, among others, against any entity that accepts or exchanges the COINYE WEST currency.

Should you wish to discuss any aspect of this matter, we suggest that you have your legal representative contact the undersigned before the above-referenced deadline.

The foregoing is not intended as a comprehensive statement of our client's rights or position, and nothing herein shall be deemed to be a waiver of any of our client's rights at law or in equity.
