**ORDER GRANTING PLAINTIFF'S EX PARTE
APPLICATION FOR LEAVE TO TAKE IMMEDIATE DISCOVERY**

Upon consideration of Plaintiffs Kanye West ("Mr. West") and Mascotte Holdings, Inc. ("Mascotte") (collectively, "Plaintiffs") *ex parte* application to take immediate discovery and the Memorandum in Support of that application;

IT IS HEREBY ORDERED that Plaintiffs may: (1) serve immediate discovery requests to obtain the identities of Defendant 0Daycoins.com ("0Daycoin Defendant") by serving third party subpoenas on the host of the website located at <0daycoin.com> for the limited purpose of seeking information sufficient to identify the operators of this website, including the names, addresses, telephone numbers, email addresses, account numbers and billing information for the operator and the names of any other websites that are run by the 0Daycoin Defendant; (2) serve immediate discovery requests to obtain the identities of Defendant Coinye-Exchange.com ("Coinye-Exchange Defendant") by serving third party subpoenas on the host of the website located at <coinye-exchange.com> for the limited purpose of seeking information sufficient to

identify the operators of this website, including the names, addresses, telephone numbers, email addresses, account numbers and billing information for the operator and the names of any other websites that are run by the Coinye-Exchange Defendant; (3) serve immediate discovery requests to obtain the identities of Defendant Newchg.com (“Newchg Defendant”) by serving third party subpoenas on the host of the website located at <newchg.com> for the limited purpose of seeking information sufficient to identify the operators of this website, including the names, addresses, telephone numbers, email addresses, account numbers and billing information for the operator and the names of any other websites that are run by Newchg Defendant; (4) serve immediate discovery requests to obtain the identities of Defendant FNU LNU a/k/a Jonny Bravo (“Bravo Defendant”) by serving third party subpoenas on the host of websites located at <coinyecasino.lv> and <coinyecasino.com> for the limited purpose of seeking information sufficient to identify the operators of these websites, including the names, addresses, telephone numbers, email addresses, account numbers and billing information for the operator and the names of any other websites that are run by the Bravo Defendant; (5) serve immediate discovery requests to obtain the identities of Defendants John Does 1 through 50 (“Doe Defendants”) by serving third party subpoenas on the host of websites located at <coinyewest.com>, <coinyeco.in>, <coinyefaucet.com>, <buycoinye.com>, <coinyecoin.org> and <coinyecoin.com> for the limited purpose of seeking information sufficient to identify the operators of these websites, including the names, addresses, telephone numbers, email addresses, account numbers and billing information for the operator and the names of any other websites that are run by the Doe Defendants; (6) serve immediate discovery requests to obtain the identities of Defendant Dogecoin (“Dogecoin Defendant”) by serving third party subpoenas on the host of websites located at <dogecoin.com>, <minecoinye.com>, <coinyemining.com>, <coinyegames.com>,

<coinyewallet.com>, <coinyestore.com>, <buycoinyes.com>, <buycoinye.net>, <buycoinye.com>, <betcoinye.com>, <coinyespin.com>, <coinyeroulette.com>, <coinyegambling.com>, <coinyepoker.com>, <coinye-dice.com>, <coinyedice.com>, <getcoinye.com>, <coinyeshop.com>, <freecoinye.com>, and <fuckcoinye.com> for the limited purpose of seeking information sufficient to identify the operators of these websites, including the names, addresses, telephone numbers, email addresses, account numbers and billing information for the operator and the names of any other websites that are run by Dogecoin Defendant; and

IT IS FURTHER ORDERED that Plaintiffs may serve immediate discovery requests by serving third party subpoenas on the host of the websites listed above for the limited purpose of seeking information sufficient to identify all other domains hosted by any of the defendants that includes the KANYE WEST, COINYE WEST, COINYE and COYE marks; and

IT IS FURTHER ORDERED that Plaintiffs may serve additional subpoenas on any leads provided in response to the above subpoena(s) to obtain information sufficient to identify each Doe Defendant and Defendants Jane Does 1 through 50.
